Closure of the Templeton Shariah Asian Growth fund (the "closing fund") Product & Policy Number: Quantum << Policy Number>>

We are writing to you with regard to your investment in the Templeton Shariah Asian Growth fund held in your policy.

Franklin Templeton International Services S.a r.l, the management company of the Franklin Templeton Shariah funds, has advised that they have decided to close the Templeton Shariah Asian Growth fund with effect from 12 December 2017, or as soon as reasonably practicable thereafter. The management company has taken this decision because the fund is of a relatively small size and they believe it is not in the best interests of shareholders to keep the fund open.

Therefore, we will be switching you out of the closing fund and redirecting future premiums into an alternative fund, the Amundi Islamic Asia Pacific Quant-C-C fund (the "receiving fund"). The receiving fund has a similar investment objective and investment risks which are comparable to that of the closing fund.

#### When will this happen?

We will switch your holdings out of the closing fund and re-direct any future premiums into the receiving fund on 5 December 2017. The switch will be carried out free of charge. The value switched-out will be the same as the value switched-in, however your policy will hold a different number of units in the receiving fund due to different unit pricing.

You will receive a switch confirmation letter shortly after 5 December 2017 to confirm your new policy holdings.

## Do I have any other options?

Yes, you do. You are free to choose any other alternative fund(s), from the range available to your policy, to switch into.

If you want to do this you will need to provide us with a signed switch instruction before 3pm UK time on 1 December 2017. If you miss the deadline, don't worry. We will switch you into the default receiving fund on 5 December 2017, after which you can still provide us with new switch instructions, as normal.

However, if you are happy to accept the receiving fund then you do not need to do anything.
