We have been advised by Franklin Templeton Investments that they are making some changes to one of their funds which impacts the investment option that your RL360° policy invests in. We wanted to make you aware of these changes and explain how you can choose a new investment option if you prefer.

Franklin Mutual Beacon 'A' (USD) (the "Investment Option")

The investment policy of the Franklin Mutual Beacon Fund, the underlying fund of the Investment Option, will be amended to more closely reflect the underlying fund's actual investment profile. The underlying fund's name will also be amended to Franklin Mutual U.S. Value Fund. In line with this, the Investment Option's name will change to Franklin Mutual U.S. Value A Acc USD.

The changes being made are for clarification only. Franklin believe the changes will provide more clarity on the underlying fund's investment focus. It will not impact the strategy or result in any additional risks. There is no change to the way the underlying fund is being managed.
