We are writing to notify you that the Board of the JPMorgan Funds are planning some changes to their JPMorgan US Dynamic Fund which you invest in via your Kudos policy.

On 31 May 2013, the JPMorgan US Dynamic Fund will merge into the JPMorgan US Dynamic 130/30 fund. Upon merging, the fund will then change name to the JPMorgan US Equity Plus Fund.

Reason for and advantage of the merger

Following significant outflows from the JPMorgan US Dynamic Fund, the Board has approved the merger with the purpose of offering shareholders of the fund the opportunity of investing in an alternative fund that has experienced superior performance historically* and that has the prospect of stronger growth in assets in the future.

Comparison of the features of the merging and receiving funds

Due to the assets of the receiving fund being invested either directly or through the use of financial derivatives there are additional risks to which the receiving fund is exposed.

The fund will then change name and you will see this called the JPMorgan US Equity Plus Fund on your valuation statement.

However, if you do not wish to continue investing in the fund you can choose to switch into any alternative investment option available to Kudos, free of any switch charge. Enclosed is a *Kudos fund performance bulletin* detailing the current fund range available. This includes performance information for the JPMorgan US Dynamic 130/30 fund which will be added to the range on 31 May 2013.

Should you wish to choose an alternative fund please complete the enclosed *Fund Switch Request* form which should be completed and returned to us. Alternatively, if you are a registered user of our Online Service Centre and fund switching facility, you can now conduct switches online fast and efficiently.

Should you wish to switch before the merger takes place please ensure we receive your completed *Fund Switch Request Form,* or you conduct a switch online, before the 23 May 2013. This will allow us time to process your instructions before the switch cut-off date set by JPMorgan.

What if I miss the switch deadline?

Don't worry. Although your holding will automatically merge into the JPM US Dynamic 130/30 Funds initially, you can still change your investment choice at any time.
