Closure of the Franklin Mutual Discovery 'A' Acc CHF Hedged Fund Policy Number: << Policy number>>

We have been informed by Franklin Templeton that they intend to close their Franklin Mutual Discovery 'A' Acc CHF Hedged fund on 26 September 2014. As you invest in this fund via your RL360° policy we are writing to let you know what this means for you and your policy.

Why is Franklin Templeton closing the fund?

The Board of Directors has taken the decision to close the fund class due to its relatively small size.

What happens now?

We have removed the fund from the <<Pre>roduct>> range with immediate effect, and we will no longer accept any new, non contractual, investments into the fund. As an existing investor we will allow your contractual regular premiums (where applicable) to continue being invested into the fund until 18 September 2014.

On 19 September 2014 we will switch your holdings out of the Franklin Mutual Discovery 'A' Acc CHF Hedged fund into the equivalent USD share class, the Franklin Mutual Discovery 'A' Acc USD fund. We will also redirect your regular premiums into this fund where applicable.

It is important for us to make you aware that although this is essentially the same fund, with the same objective, annual management charge and risk profile, it is denominated in a different currency and may introduce additional currency risk into your portfolio. We therefore suggest that this would be a good time to review your portfolio and discuss the potential impact with your financial adviser.

What options do I have?

If you are unhappy that we will be switching your holding into the Franklin Mutual Discovery 'A' Acc USD fund, you can tell us at any point up until 19 September 2014 to switch into another fund of your choice..
