This letter contains important information about your investment in a Sub-Fund in the BNY Mellon Investment Funds (BNY MIF) umbrella.

No action is required from you for the changes below to take effect.

We are writing to you because you are invested in a Sub-Fund(s) listed overleaf.

To ensure consistency across our fund ranges, we have decided to align the names of the Sub-Funds in BNY MIF with the global investment parent company, BNY Mellon. As such, we are changing their naming convention. Please see overleaf for the existing and replacement names.

The UK regulator, the Financial Conduct Authority, has approved these changes and confirmed that they will not affect the ongoing authorisation of the Sub-Funds. There is no change to the way the Sub-Funds are managed.

The new Sub-Fund names will be effective on 10 June 2019.

Copies of the revised Prospectus, Instrument of Incorporation and Key Investor Information Documents incorporating the changes to the Sub-Fund names will be available on request and from our website, <u>www.bnymellonim.com</u> from 10 June 2019.
