CHANGES TO THE THREADNEEDLE UK CORPORATE BOND FUND AND IMPACT ON RL360 POLICIES

Columbia Threadneedle ("Threadneedle") has announced that it will be renaming its UK Corporate Bond Fund to Sterling Corporate Bond Fund on Friday 31 August 2019. In addition Threadneedle is also changing the fund's investment objective and policy. As you provide advice to one or more policies invested in the fund we wanted to make you aware of the changes and explain your options for switching to a different fund if you prefer.

The policies advised by you and impacted by this notification are listed at the end of this letter. We have not written directly to the owners of the policies listed. As each policyholder has appointed your company in the capacity of investment adviser to manage the investment choices on their behalf, you should contact your clients as necessary to discuss the details of this notification and any recommended course of action.

Impact of the changes

Threadneedle is making some changes to the wording of the investment objective and policy of the fund to allow the fund to invest more broadly in sterling denominated bonds and provide more detail and clarity of how the fund is invested.

The new investment objective and policy reflect that the fund invests mainly in investment grade sterling denominated corporate bonds issued by UK companies and non-UK companies, and corporate bonds issued in other currencies that have been hedged back to sterling. The fund already holds some investments in countries worldwide, and this revised description has the effect of allowing the fund to hold a greater proportion of bonds from issuers outside of the UK and Europe, if that is considered appropriate. Please refer to the table overleaf for a comparison of the changes.

The changes will not affect the way the fund is managed nor change the risk profile of the fund.

Your options

If you are happy with these changes, you don't need to do anything. However, if you would prefer to switch to a different fund, it's free of charge, and very easy to do.

<p>To achieve a high level of income.</p> <p>The Authorised Corporate Director (ACD)'s investment policy is to invest the assets of the fund primarily in fixed interest investments in the UK and Continental Europe.</p>	<p>The fund aims to achieve a return over the long term (5 year or more), consisting of income with some capital growth.</p> <p>The fund is actively managed, and invests at least two-thirds of its assets in investment grade corporate bonds that are denominated in sterling (or hedged back to sterling, if a different currency), issued by UK companies and companies worldwide. In addition, the fund may invest in other bonds (including below investment grade corporate bonds, and government bonds) when considered appropriate to achieve its investment objective.</p> <p>The fund may also invest in collective investment schemes (including funds managed by Columbia Threadneedle companies), money market instruments, deposits, cash and near cash.</p> <p>The fund is not permitted to invest in derivatives for investment purposes, but derivatives may be used with the aim of reducing risk or managing the fund more efficiently.</p>
