CHANGES TO THE FUND RANGE FOR RL360 REGULAR SAVINGS PLAN, REGULAR SAVINGS PLAN MALAYSIA, PARAGON, ORACLE, QUANTUM AND QUANTUM MALAYSIA.

We regularly review the funds available to our savings and investment products to ensure that plan owners continue to have access to a high quality and diverse range of funds, to help them meet their investment goals. We have recently completed a review of some of our investment sectors in the range.

The review process considers the performance and risk profile of funds within the range to determine whether they continue to provide the right outcomes for investors and remain appropriate for the product. We also consider new additions that would offer something attractive or complementary to the range. As a result, we are intending to remove **ten** of our existing funds from the range (14 including currency variants), whilst adding **three** additional funds (Three including currency variants). These amendments to the range sit within the Global Equity, Global Bond, UK Equity and Asian Bond sectors.

What does this mean?

Your clients are invested in one or more of the funds that we are removing from the range, detailed below. We have selected alternative funds and they will be switched into these automatically (including any regular payment allocation) between 20 July and 3 August 2022. They can remain invested in the closing fund(s) they hold until the date we switch them.

If you are happy with our choice of receiving fund then you do not need to do anything. However, if you would prefer to switch to a different fund, it's free of charge and very easy to do.
